

I. Internationalisation is (also) a topic for dual study courses (1)

Companies need international staff

- Large- and medium-sized companies have clients, partners and even head offices worldwide
- Employees need to have good language and intercultural skills
- BUT: Internationalisation is not a main focus of companies so far

Assessment of the importance of internationalisation



I. Internationalisation is (also) a topic for dual study courses (2)

- **Students wish to gain an international perspective**
 - According to a non-representative study (HWR Berlin), 83% of students in dual study courses are interested in gaining an international experience
 - BUT: the level of internationalisation is much lower
- Internationalisation as marketing tool

II. Organising mobility windows in dual study programmes is challenging...

Challenges regarding the internationalisation

- Not all employer are interested
- Rigorous and tight schedule
- Tailor-made programmes abroad?
- Incoming students – exchange balance
- Funding for studies abroad
- Workload for students

III. ...but possible! (1)

Outgoing	
1. Theory term	1a. Dual students from Germany complete a theory term at a praxis-oriented university abroad
2. Praxis term	2a. Dual students from Germany complete a praxis term with a company abroad
3. Direct combination of theory & praxis terms	3a. Dual students from Germany complete a direct combination of theory and praxis abroad
5. Bi- or tri-national dual study programme	A dual study programme based in Germany is created as an integrated programme in collaboration with a praxis-oriented partner university abroad; students automatically complete part of their studies on the campus abroad; the collaboration can be expanded to include more than two countries
6. Complete degree	6a. A person from Germany completes their entire degree at a university abroad offering a programme similar to the dual studies model

+ internationalisation at home

- International course content
- Courses in English
- International lecturers
- Incoming students
